# **Teprotumumab**

This information from Lexicomp® explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

# What is this drug used for?

• It is used to treat Thyroid Eye Disease.

# What do I need to tell my doctor BEFORE I take this drug?

- If you are allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell your doctor about the allergy and what signs you had.
- If you have high blood sugar (diabetes) that is not controlled.

This drug may interact with other drugs or health problems.

Tell your doctor and pharmacist about all of your drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe for you to take this drug with all of your drugs and health problems. Do not start, stop, or change the dose of any drug without checking with your doctor.

# What are some things I need to know or do while I take this drug?

- Tell all of your health care providers that you take this drug. This includes your doctors, nurses, pharmacists, and dentists.
- High blood sugar has happened with this drug. Check blood sugar as you have been told. Talk with the doctor if you have questions.
- If you have inflammatory bowel disease (IBD), talk with your doctor. Worsening of IBD has happened. Tell your doctor if your signs get worse when taking this drug.
- This drug may cause harm to the unborn baby if you take it while you are pregnant.
- If you may become pregnant, you must use birth control before starting this drug, while taking it, and for some time after the last dose. Ask your doctor how long to use birth control. If you get pregnant, call your

- doctor right away.
- Tell your doctor if you are breast-feeding. You will need to talk about any risks to your baby.

# What are some side effects that I need to call my doctor about right away?

WARNING/CAUTION: Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your doctor or get medical help right away if you have any of the following signs or symptoms that may be related to a very bad side effect:

- Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.
- Signs of high blood sugar like confusion, feeling sleepy, unusual thirst or hunger, passing urine more often, flushing, fast breathing, or breath that smells like fruit.
- No period or other period (menstrual) changes.
- Infusion reactions have happened during or after the infusion. Tell your doctor right away if you have

effects like fast heartbeat; feeling hot; shortness of breath; muscle pain; or signs of high blood pressure like headache, dizziness, passing out, or change in eyesight.

 This drug may cause a change in hearing or hearing loss that may not go away. Tell your doctor right away if you have ringing in the ear, a change in hearing, or hearing loss.

# What are some other side effects of this drug?

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your doctor or get medical help if any of these side effects or any other side effects bother you or do not go away:

- Muscle spasm.
- Upset stomach.
- Diarrhea.
- Hair loss.
- Weight loss.
- Feeling tired or weak.
- Change in taste.
- Dry skin.

• Change in nails.

# How is this drug best taken?

Use this drug as ordered by your doctor. Read all information given to you. Follow all instructions closely.

- It is given as an infusion into a vein over a period of time.
- Other drugs may be given to help with infusion side effects.

#### What do I do if I miss a dose?

Call your doctor to find out what to do.

### How do I store and/or throw out this drug?

• If you need to store this drug at home, talk with your doctor, nurse, or pharmacist about how to store it.

### General drug facts

- If your symptoms or health problems do not get better or if they become worse, call your doctor.
- Do not share your drugs with others and do not take anyone else's drugs.
- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush down a toilet or pour down a drain unless you are told to do so. Check with your pharmacist if you have questions about the best way to throw out drugs.
  There may be drug take-back programs in your area.
- Some drugs may have another patient information leaflet. If you have any questions about this drug, please talk with your doctor, nurse, pharmacist, or other health care provider.
